- **D. Key Club (Paul)** Paul reported that clubs will hold elections 2/16 && 2/17. DCONN paper work is due by March 1st. Paul will drive the van for Union and Gretchen will most likely drive the Visa Grande van. Our club donates \$500 to each school to help offset the cost of attendance. Key Club officers are required to go; usually class reps and paper editor go as well. Kids pay \$75; the club pays an additional \$50. Installation of officers will be sometime in mid-March.
- **E. K-Kids** (**Richard**) *Richard reported that we need to schedule a date/time to present the charter and install the officers. He will research what needs to be done to deal with the school's name change.*

Board Vacancy: Notification of the opening is to Club members is to be done a minimum of 14 days prior to balloting. Linda will send email to the members to notify them nominations will occur on 2/11 and balloting on 2/18.

Newspaper ads: Paul suggested we include an ad in inserts dedicated to FFA (\$24.24 + tax) and the Boys & Girls Clubs of the Casa Grande Valley (\$45 + tax). A discussion followed regarding the need for committees to see approval of using budgeted funds. The board members agreed that Committees have the authority to use budgeted funds for as intended. Therefore, Paul's committee should make the decision regarding taking out the afore mentioned ads. Gary suggested we look at doing an insert like the ones for FFA and Boys & Girls Clubs.
