E. Committee Reports

- a. Administration (Gary) The Club held elections last week. Joe Lopez was elected President, Steve Graham will be the President-Elect, Gary Smothers will take the Past President seat, Dan Anderson will continue as Treasurer and Linda Lewandowski remains Club Secretary. c. Finance & Fundraising (Maggie)

Only one \$20 sale was through a credit card. The next sales date will be Saturday, June 19th. Paul and Richard developed an ad for the newspaper, which will run twice. - d. **Membership/Growth & Education (Keith)** Though Keith is in Iowa until some time in August, we discussed a suggestion that we provide a new/prospective member with some orientation; that the proposer act as mentor. Talk with the new or prospective member about what we do and how they can help. Perhaps the proposer could take the new/prospective member to lunch or out for a beverage and have a discussion there rather than at a meeting. Develop a checklist for the proposer/mentor to use in helping the new person understand, not just to give to the new member.
- e. **Public Relations/Advertising (Richard)** The raffle ads will run in the local paper twice.
