Executive Board Meeting Thursday, March 5th 6:00 a.m. Holiday Inn, Casa Grande, AZ

A. Call to Order: Roll Call

B. Approve February 5th 2015 Minutes

Minutes were approved as written.

C. Reports

C.1 Treasurer's Report (Dan)

Dan reported that we have a total of \$9,123.88. \$25 cash on hand, \$1,464 in checking, \$2,500 dues, \$3,918 in the project account.

C.2 Secretary's report (Linda)

Linda reported the monthly report for February has been submitted.

C.3 Membership (Scott)

Our membership stands at 26 members and 3 potential members: Principle of CG Union HS, AirEvac and Scott's Assistant Chief. The hope is Tim Hamilton will retain his membership after his retirement. Also, need to approach the incoming Principle for Vista Grande HS.

C.4 Key Club (Paul)
